4. Proof of Eligibility: Reference National By-Laws and Manual of Procedure Section 416, District Officers, elected and appointed, shall submit proof of eligibility to the District Adjutant. Additionally District Commanders, District Senior Vice Commanders, and District Junior Vice Commanders shall submit proof of eligibility to the Department Adjutant.

5. Elected District Officers: Attention of newly elected District Officers is directed to Section 418, Manual of Procedure, which outlines the duties of each District Officer.

6. District Meeting Attendance: Section 218 of the National By-Laws and Manual of Procedure, Veterans of Foreign Wars of the United States, states in part: "He" (Post Commander) or his representative (Sr. Vice or Jr. Vice), shall attend all regularly called District Convention or District Meetings. Failure without just cause to perform this duty shall result in removal from office. This and all other provisions of the National By-Laws and Manual of Procedure will be enforced. District Commanders are directed to report (in writing) two or more unexcused absences of Post's Commander, Sr. Vice Commander, Jr. Vice Commander at District Meetings/Convention. **Note:** ONLY District Commander may excuse. The report will include the actions taken by the District Commander to gain their attendance and participation
